JUDGMENT

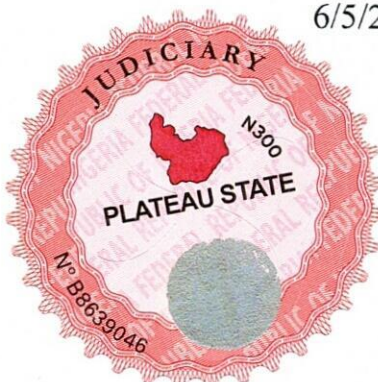
