**CLAIM: THE SUM OF TWO HUNDRED AND EIGHTEEN THOUSAND
(N218,000.00) NAIRA**

INTEREST OF N100,000.00 ON LOAN AND N40,000.00 COST OF ACTION

CLAIMMANT

All the defendants together are owing me the total sum of N218,000. And if I was trading with my money, it would have accrued N100,000 as interest and all the expenses i have incurred as cost of this action is N40,000.

DEFENDANTS JOINTLY:

We have heard the claim of the claimant, but his money is not up to that amount because we were not given the last N15,000 by the person who was the by name Abednego.

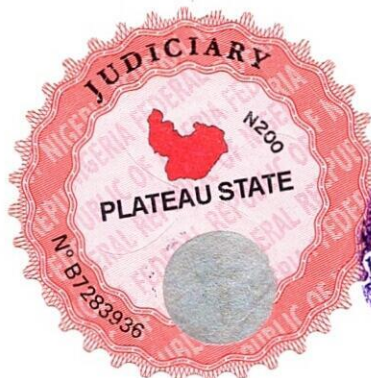
COURT

In view of the disparities between the parties, as per the actual amount of the sum been claimed, the court will adjourn this matter to another date to enable parties sit together and iron out their differences so as to arrive at the actual amount the defendants are owing jointly and severally

Case is hereby adjourned for one week to 11th March 2024

Parties: all present in court except Abednego

Claimant: we all sat down together with the defendants and we have come up with the total sum the defendants are owing me, which is now N203,000, two hundred and three thousand naira only as the defendant claimed that the last N15,000, fifteen thousand naira got missing in the hand of Abednego the 8th defendant.

DEFENDANTS JOINTLY; that is the total sum we are owing the claimant

CLAIMMANT; I am also claiming N100,000 AS INTEREST and N40,000 AS COST OF ACTION.

DEFENDANTS; we plead with the court to stand down this matter a little to allow us resolve the issue of interest and cost of action.

COURT; This matter is hereby stood down for one hour to enable parties resolve the issues raised above.

COURT RESUME AFTER RECESS

CLAIMMANT; we have agreed for the sum of forty thousand naira as cost of action, making the total of N243,000, that is the amount the defendant are jointly owing

I am dispensing the issue of interest on loan.

Defendants jointly; that is the amount we have all agreed upon. And we are pleading with the court to give us one month within which to pay up the money we are owing the claimant

CLAIMMANT; one month is too much i cannot give them up to that time

CONSENT JUDGEMENT

Since all the parties have agreed on the total sum of money being owed jointly by the defendants as per the claimant's particulars of claim. The Court will go ahead and enter same as consent judgment of the sum owed. Consequently, each of the defendants is to pay to the claimant the sum of twenty-seven thousand Naira each i.e. N243,000 divided by nine persons which is equals to N27,000 each.

That is the judgement of the court
